Collector asks officials to speed up works at tribal university

VIZIANAGARAM

Vizianagaram Collector B.R. Ambedkar on Thursday directed the officials concerned to take steps for the speedy completion of works of Central Tribal University of Andhra Pradesh so that classes could be commenced in new buildings from the 2025-26 academic year.

He visited the project site at Dattirajuru-Mentada mandals and inquired about the progress and quality of the works. The officials told him that boys' hostel, administrative buildings, mess, and guest houses were being constructed in the phase-I and others would be completed as per the schedule.

Mr. Ambedkar said that



the government had allocated 560 acres of land for the university. Water, electricity and other amenities on the campus would be improved. University administrative officer N.V.S. Suryanarayana said that the new buildings would help students to have more facilities in the absence of full-fledged infrastructure in the temporary campus located at AU buildings in Vizianagaram.
