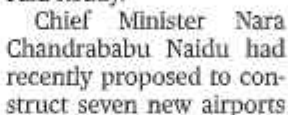


She said manual booking for sand would continue as part of a temporary arrangement until an on-line platform was developed, adding that the portal was likely to be introduced in the second week of September.

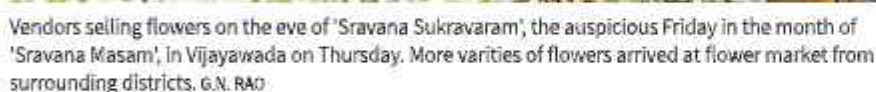
Mr. S. Satish Kumar said that the vehicles transporting sand illegally would be seized.

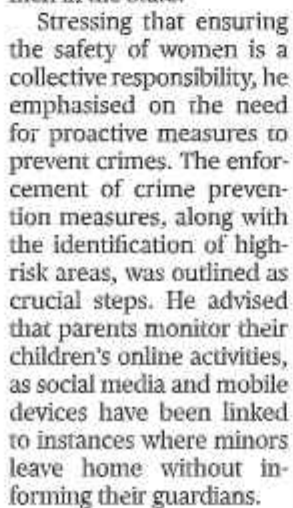

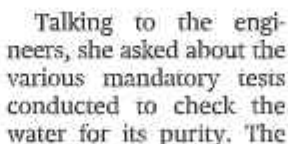
